PLEASE NOTE: Completed form with cheque must be in the hands of the State Secretary by Friday 9 February 2018, otherwise it will be treated as a late nomination. **SSA/ASCF (Inc) Drivers License number, Log Book & Decal number** must be included on the Nomination Form or the nomination **will not** be accepted.

FORMAT: Day One

- Each driver to have three heats of ten laps.
- Maximum of twelve cars in each heat.
- Points in the heats: 36, 28, 23, 17, 13, 10, 8, 6, 5, 4, 3, 2, 1.

FORMAT: Night Two

- Each driver to have one heat of ten laps.
- Maximum of twelve cars in each heat.
- Points in the heats: 36, 28, 23, 17, 13, 10, 8, 6, 5, 4, 3, 2, 1.
- All three scores will count with top 16 automatically qualifying for the A Main.
- Qualifiers 17 to 32 will compete in the B Main with the first four from this event qualifying for the A Main.*
- ~~Qualifiers 33 to 50 will compete in the C Main with the first two from this event to start at the back of the B Main.*~~
- ~~The C Main to be the number of cars plus one lap (maximum 19 laps)~~
- The B Main will be conducted over 20 laps
- The A Main will be run over 35 laps.

*Please note that from 2011/2012 each final will be a "full field" so if a driver who qualifies for a final is unable to compete, the next highest qualifier will be taken, and subsequently more than two from the C Main may be taken to the B Main, and more than four may be taken from the B Main to the A Main. Drivers will be advised prior to the race should there be a change to the normal transfer qualifications. Should there be less than 22 entries there will be no C or B Main, with all drivers to qualify for the final, with final points determining all starting positions.

Trophies down to fourth place
Sashes down to fourth place
Medallions for all Finalists

TOW MONEY: \$2,200

\$2,200 divided into all Cars traveling over 350 km one-way.

PRIZEMONEY: \$5,000

\$5,000 paid as per National policy on percentage basis over C,B & A Mains

PRACTICE: Friday, 2 March 2018, from 4.00pm to 6.00pm. .

SCRUTINEERING: Saturday, 3 March 2017 by appointment from 10.30am. Appointed scrutineering times will be notified to each nominated driver. Depending on number of cars entered this time may change. **Re-Checks:** To be completed prior to racing.

N.B. Driver and race attire must be with race vehicle at scrutineering. Venue for Scrutineering will be Speedway Pit Area.

WELCOMING FUNCTION/DINNER/CALCUTTA: Friday, 2 March 2018 – 7.00pm

DRIVERS BRIEFING: Full Drivers Briefing in the Club Rooms 5.00pm.

PASSES: One pass for Driver and three for Pit Crew. These passes will be available once the car passes Scrutineering. All Drivers and Pit Crew to have Insurance Cards.

PROMOTION: A current photo of yourself and your car is required for this Event. Also the attached profile form must be filled out and returned with the photo.

PRESENTATION OF TROPHIES: Will be made immediately following the final, with all placings provisional, until cars have been checked for legality. Trophies and sashes will be reclaimed after the presentation until such time as cars have passed Scrutineering checks. Should there be an appeal, trophies and sashes will be retained by State Secretary until appeals have been heard.

LICENSE & LOG BOOK: Are to be handed in to Allan Smallwood at scrutineering and obtained from Allan at the conclusion of the race meeting.

CONDITIONS OF ENTRY:

1. Open to all Registered and Licensed SSA/ASCF (Inc) competitors, who hold a current ASCF/SSA Infringement Card and Log Book, and hold a Speedway Australia License Card.
2. All vehicle engines must be sealed.
3. All nominations received after Friday, 9 February 2018, will be classed as a late nomination. No excuses will be accepted, regardless of circumstance.
4. All late nominations will be included in the Grid Draws after paying \$500 late nomination fee.
5. Late nominations will not be accepted after Friday, 2 March 2018 (4pm).
6. One Way communicators are compulsory for this event. They will not be hired out.
7. Nomination fee once received, will not be refunded under any circumstances.
8. All accepted nominations will be advised with Scrutineering times. Grid Draws will not be advised until after Practice is completed and will be issued at the completion of the drivers meeting. They will appear on speedwaysedans.com as part of a media release.
9. Withdrawals must be notified 48 hours prior to commencement of Meeting to Jason Crowe (State Secretary), on 0428 211 484. **Failure to do so will incur a \$100.00 fine.**
10. The WASCF (Inc) reserve the right to refuse any entry.
11. This is a Speedway Sedans Australia Sanctioned event conducted by Speedway Sedans WA. As such ALL drivers competing must be a registered driver with Speedway Sedans Australia, your car must be registered with Speedway Sedans Australia, You must have a valid Infringement Card, and you must hold a Speedway Australia Card. Failure to comply with this will see your nomination refused.
